

Definitions: The Price to Earnings Ratio is calculated by dividing current price of the stock by the company's trailing 12 months' earnings per share. Return on Equity is a measure of a corporation's profitability and represents the average return on equity on the securities in the portfolio, not the actual return on equity on the portfolio. Return on Average Invested Capital is calculated as last twelve months divided by the two fiscal period average of Total Invested Capital, multiplied by 100. The S&P 500 Index is the Evercore Equity Fund's benchmark.
